Dear Parent/Guardian

Teenage Booster Immunisations: offer of Meningococcal ACWY (MenACWY) and combined Tetanus, Diphtheria and Poliomyelitis (Td/IPV) vaccines to ALL children in Year 9, as well as children in Years 10 and 11 who have previously missed their vaccines.

We are pleased to confirm that these vaccinations will be provided in schools to help protect your child against Tetanus, Diphtheria, Poliomyelitis and four types of meningococcal bacteria (groups A, C, W and Y) that can cause meningitis (inflammation of the lining of the brain) and septicaemia (blood poisoning). These diseases are very serious and can kill, especially if not diagnosed early. Your child is now due these two vaccines, so that protection against these diseases will continue in adult life.

Once you receive this offer letter you should complete the consent form (linked below on page 2) as soon as possible. It is important for you to discuss the consent form together with your child, please do this even if you don't want your child to receive the vaccination. Please be aware that if we do not receive the completed consent form, a young person may be assessed on an individual basis and invited to self-consent for the vaccination providing they can demonstrate an understanding of the vaccination offered to them. This approach is in line with the Gillick Competency Framework, please note we would only do this if we cannot get hold of a parent or guardian.

- InHealthCare will send a verification code to your email address, to ensure we have your correct details.
- You will be asked a series of health questions for your child. There is space to add further information
 if your child has a health condition or additional needs.
- We will contact you if we require any further information. Please provide a daytime telephone number if possible.
- If you miss the deadline you can still complete a form but will be offered an appointment for a catchup clinic at a community venue.
- If you decide you do not want your child to be vaccinated, there is a box on the consent form for you to complete and please do tell us why.

Your child may have already had the Td/IPV vaccine at an Emergency Department if they have attended following a tetanus prone wound. If this is the case, when you complete the online form please let us know when this was given, so we can advise whether the booster is needed.
